

Supplement to the pickup slip with details of the person collecting the vehicle

As a buyer, you now have option to give the name of the person collecting the vehicle on the pickup slip with immediate effect. When entered like this, the latter is authorised to collect the vehicle and no separate authorisation is needed any more.

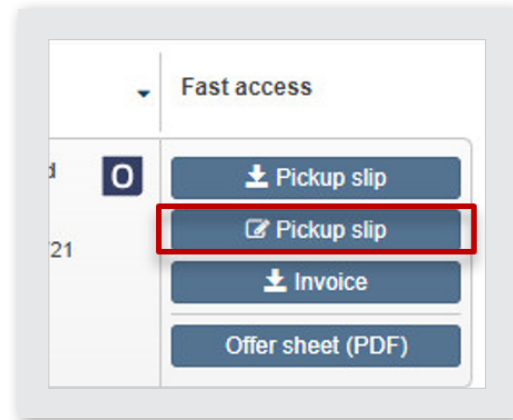
How does this work?







Here are our step-by-step instructions:

Version A:

Entry via „My Autobid.de – My vehicles“

- 01 Call up the “My Autobid.de – My vehicles” page.
- 02 Select the vehicle you want to collect and click on the blue button on the right “Pickup slip with editing button”

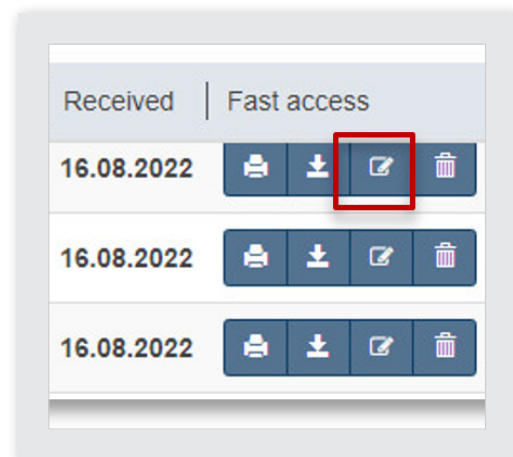








- 01 Go to “My Autobid.de” and call up your mailbox.
- 02 Select the vehicle to be collected in the pickup slip list via the editing button.

- (1) Enter the person who will be collecting the vehicle (yourself, third-party individual, freight forwarder, no details). If you click on "no details", if the person collecting the vehicle is not the buyer according to the purchase contract, he will have to bring authorisation with him as before.

- (2) Enter the precise name of the person/freight forwarder collecting the vehicle.

- (3) Choose whether the motor vehicle registration certificates should be handed to the person collecting it or sent by post.

- (4) Save and print out the pickup slip.
